**ROADS**

**The Private Access at No. 168 Dublin Road, Loughbrickland  
(Stopping-Up) Order (Northern Ireland) 2011**

*Made* - - - - *16th May 2011*

*Coming into operation* - *8th June 2011*

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Article 69(1)(a) of the Roads (Northern Ireland) Order 1993(b) and now vested in it(c).

The Department, in accordance with Article 69(1) of that Order considers that the use of a private means of access from Dublin Road, Loughbrickland to land situate at No. 168 Dublin Road, Loughbrickland in the Townland of Meenan is likely to cause danger to, or interfere unreasonably with traffic on that road.

The Department, in accordance with Article 69(2)(a) of that Order, is satisfied that access from the road to the land is not reasonably required.

Notice has been published and served in compliance with paragraphs 1, 2 and 3 of Schedule 5 to that Order.

No objection has been received.

**Citation and commencement**

1. This Order may be cited as The Private Access at No. 168 Dublin Road, Loughbrickland (Stopping-Up) Order (Northern Ireland) 2011 and shall come into operation on 8th June 2011.

**Application**

2. The private access at No. 168 Dublin Road, Loughbrickland shall be stopped-up to motor vehicles at the line described in the Schedule.

**PRIVATE ACCESS TO BE STOPPED-UP**


Article 2
