The Northern Ireland Court of Judicature Rules Committee^(a) makes the following Rules in exercise of the powers conferred by sections 55 and 55A of the Judicature (Northern Ireland) Act 1978^(b).

Citation, commencement and interpretation

1.—(1) These Rules may be cited as the Rules of the Court of Judicature (Northern Ireland) (Amendment No.3) 2011 and come into operation on 25th July 2011.

(2) In these Rules an Order or Form referred to by number or an Appendix referred to by letter means the Order or Form so numbered or the Appendix so lettered in the amended Rules.

Amendment

2. In Order 93 of the Rules of the Court of Judicature (Northern Ireland) 1980^(c), after rule 1(2)(t), insert—

“(u) the Transnational Information and Consultation of Employees Regulations 1999^(d).”
