**The Waiting Restrictions (Newtownabbey) (Amendment) Order
(Northern Ireland) 2011**

Made - - - - - *15th September 2011*

Coming into operation - - - - - *7th October 2011*

The Department for Regional Development^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Waiting Restrictions (Newtownabbey) (Amendment) Order (Northern Ireland) 2011 and shall come into operation on 7th October 2011.

Amendment

2.—(1) The Waiting Restrictions (Newtownabbey) Order (Northern Ireland) 2008^(d) shall be amended in accordance with paragraphs (2) and (3).

(2) In Article 2 (restriction of waiting) for the word “length” substitute “lengths”.

(3) For the Schedule substitute the Schedule set out in the Schedule to this Order.

Article 2

No Waiting at any Time

All in Newtownabbey

1. The bus turning circle located opposite No. 698 Shore Road, (southern kerb line) – from the entrance junction with Shore Road to the exit junction with Shore Road, for a distance of 91 metres broken only by the existing bus stop markings.
2. Farrier Court, (north side) – from a point 25.5 metres east of its junction with Antrim Road in an easterly and then northerly direction for a distance of 30 metres.
3. Farrier Court, (north side) – from a point 5.5 metres south of the northern end of the turning head adjacent to Church Road in a south-easterly direction for a distance of 37 metres.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Waiting Restrictions (Newtownabbey) Order (Northern Ireland) 2008 (“the 2008 Order”) by substituting the Schedule specified in the Schedule to this Order for the Schedule to the 2008 Order. The effect is to prohibit vehicles waiting at any time on the lengths of road specified in the Schedule.

Vehicles are excepted from the prohibitions in certain circumstances.

A penalty charge (£60) is payable with respect to a vehicle involved in a contravention of the 2008 Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the roads.
