The Off-Street Parking (Amendment No. 2) Order (Northern Ireland) 2012

Coming into operation - *18th July 2012*

The Department for Regional Development^(a) makes the following Order in exercise of the powers conferred by Article 13(14) and (15) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

Citation and commencement

(2) For Schedule 4 substitute the Schedule set out in the Schedule to this Order.
