ROAD TRAFFIC AND VEHICLES

The Waiting Restrictions (Dungannon) Order (Northern Ireland) 2013

Made - - - - 26th September 2013

Coming into operation - 16th October 2013

The Department for Regional Development(**a**) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation, commencement and interpretation

- **1.**—(1) This Order may be cited as The Waiting Restrictions (Dungannon) Order (Northern Ireland) 2013 and shall come into operation on 16th October 2013.
 - (2) In this Order —

"medical practitioner" means a registered person within the meaning of the Medical Act 1983(d);

"postal packet" means a letter, parcel, packet or other article transmissible by post as defined in section 125 of the Postal Services Act 2000(e); and

"universal service provider" has the same meaning as in section 4(3) and (4) of the Postal Services Act 2000.

Restriction of waiting

- 2. Save as provided in Article 3, a person shall not cause or permit a vehicle to wait
 - (a) at any time on the lengths of road specified in Schedules 1 and 2; and

(b) during the hours between 8.30 a.m. and 6.15 p.m. on the days Monday to Saturday inclusive on the lengths of road specified in Schedule 3.

Exceptions

- **3.**—(1) Nothing in Article 2 shall render it unlawful for a person to cause or permit a vehicle to wait on the carriageway of a length of road specified in the Schedules where the person in control of it is prevented from proceeding by circumstances beyond that person's control or to avoid an accident or for so long as may be reasonably necessary to enable—
 - (a) a person to board or alight from a vehicle provided that such boarding or alighting does not cause the vehicle to wait in the same place for more than 2 minutes;
 - (b) the vehicle to be used in an emergency by a medical practitioner, or for fire and rescue, ambulance, police or customs purposes or the purposes of the security forces;
 - (c) the vehicle to be used by or on behalf of a universal service provider for the purposes of the delivery to, or collection from, premises situated adjacent to the length of road of postal packets;
 - (d) the vehicle, if it cannot conveniently be used for such purposes outside that length of road, to be used—
 - (i) in connection with any building, repair or demolition operations;
 - (ii) in connection with the removal of any obstruction of traffic;
 - (iii) by or on behalf of a district council or a government department in pursuance of statutory powers or duties;
 - (iv) by or on behalf of a sewerage undertaker or a water undertaker in connection with the discharge of that undertaker's functions;
 - (v) in connection with the discharge of the functions of the holder of a licence granted under Article 10 of the Electricity (Northern Ireland) Order 1992(a) or of a licence granted under Article 8 of the Gas (Northern Ireland) Order 1996(b); or
 - (vi) in connection with the laying, erection, alteration or repair of any electronic communications apparatus as defined in Schedule 2 to the Telecommunications Act 1984(c).
- (2) Nothing in Article 2 shall render it unlawful to cause or permit a vehicle to wait on the carriageway of a length of road specified in Schedule 1 or Schedule 3 for so long as may be reasonably necessary to enable goods to be loaded or unloaded from the vehicle.
- (3) For the purposes of paragraph (1)(a) a vehicle shall be deemed to wait in the same place for more than 2 minutes if any one part of the carriageway is below any part of the vehicle or its load (if any) throughout the period exceeding 2 minutes whether or not the vehicle is moved during that period.

Revocations

4. The Orders specified in Schedule 4 are revoked.

Article 2(a)

No Waiting at any Time (Loading and Unloading Permitted)

All in Dungannon

- 1. Dunlea Vale (north-east side) from a point 15 metres south-east of its junction with Oaks Road, for a distance of 90 metres in a south-easterly direction.
- 2. Fairview (both sides) from its junction with Gallows Hill, for a distance of 14 metres in a south-westerly direction.
- 3. Gallows Hill (both sides) from its junction with Fairview, for a distance of 15 metres in a north-easterly direction.

Article 2(a)

No Waiting at any Time (Loading and Unloading Not Permitted)

All in Dungannon

- 1. Killyman Road, Route B34 (north-east side) from a point 560 metres north-west of its junction with the B517 Far Circular Road, for a distance of 110 metres in a north-westerly direction.
- 2. Killyman Road, Route B34 (south-west side) from a point 560 metres north-west of its junction with the B517 Far Circular Road, for a distance of 110 metres in a north-westerly direction.

Article 2(b)

Waiting Restriction (Loading and Unloading Permitted) — Monday to Saturday 8.30 a.m. to 6.15 p.m.

All in Dungannon

- 1. Ballygawley Road (south-west side) from a point 15 metres north-west of its junction with Linfield Street, for a distance of 121 metres in a north-westerly direction.
- 2. Barrack Street (north-east side) from a point 15 metres south-east of its junction with Scotch Street, for a distance of 125 metres in a south-easterly direction.
- 3. Thomas Street (east side) from a point 15 metres north of its junction with Feeney Lane, for a distance of 16 metres in a northerly direction.
- 4. Union Place (north-west side) from a point 44 metres north of its junction with Greers Road, for a distance of 39 metres in a north-easterly direction.
- 5. Union Place (north-east side) from a point 105 metres north-east of its junction with Greers Road, for a distance of 40 metres in a south-easterly and south-westerly direction.
- 6. Union Place (south-east side) from a point 53 metres north of its junction with Greers Road, for a distance of 48 metres in a north-easterly and south-easterly direction.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order prohibits vehicles waiting on the roads and lengths of road specified in:—

- (a) Schedule 1 at any time (loading and unloading permitted);
- (b) Schedule 2 at any time (loading and unloading not permitted); and
- (c) Schedule 3 during the hours 8.30 a.m. to 6.15 p.m. on the days Monday to Saturday inclusive (loading and unloading permitted).

The Order will also revoke the Orders specified in Schedule 4 and re-enact the waiting restrictions to allow loading and unloading on lengths of Gallows Hill, Fairview and Dunlea Vale; at any time and on lengths of Union Place, Barrack Street, Ballygawley Road and Thomas Street between 8.30 a.m. and 6.15 p.m. Monday to Saturday;

Vehicles are excepted from the prohibition in certain circumstances (Article 3).

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the roads.
