**The General Dental Services (Amendment)
Regulations (Northern Ireland) 2016**

Made - - - - *16th September 2016*

Coming into operation *10th October 2016*

The Department of Health⁽¹⁾, in conjunction with the Department of Finance, in exercise of the powers conferred by Articles 55A(1)(a), 61(1) and (2), 106 and 107(6) of the Health and Personal Social Services (Northern Ireland) Order 1972⁽²⁾ makes the following Regulations:

In accordance with Article 61(4) of that Order, the Department has consulted with such organisations as appear to be representative of the dental profession.

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the General Dental Services (Amendment) Regulations (Northern Ireland) 2016 and shall come into operation on 10th October 2016.

(2) In these Regulations “the principal Regulations” means the Health and Personal Social Services General Dental Services Regulations (Northern Ireland) 1993⁽³⁾.

Amendment of regulation 19 of the principal Regulations

2. In regulation 19 of the principal Regulations (Statement of Dental Remuneration), for the Table in paragraph (1) substitute—

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Health and Personal Social Services General Dental Services Regulations (Northern Ireland) 1993 which regulate the terms on which general dental services are provided under the Health and Personal Social Services (Northern Ireland) Order 1972.

Regulation 2 amends regulation 19 of the principal regulations to reflect the new numbering of determinations relating to matters set out in the Statement of Dental Remuneration following the ceasing of commitment payments to dentists.

Regulation 3 amends the dentists terms of service contained in Schedule 2 of the principal regulations to enable a dentist to keep all referred forms of records detailed in the Regulations, including the practice record form, in computerised form.
