**The Roads (Classification) Order (Northern Ireland) 2017**

*Made* - - - - - *4th September 2017*

*Coming into operation* - - - - - *25th September 2017*

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 13 of the Roads (Northern Ireland) Order 1993<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

**Citation and commencement**

1. This Order may be cited as The Roads (Classification) Order (Northern Ireland) 2017 and shall come into operation on 25th September 2017.

**Classification**

- 2.—(1) The road described in Schedule 1 is classified as being a first-class road.  
(2) The road described in Schedule 2 is classified as being a second-class road.  
(3) The road described in Schedule 3 is classified as being a third-class road.

**Revocations**

3. The items specified in column 3 of Schedule 4 contained in the provisions specified in column 1 of that Schedule are revoked.
