**The Dunbar Link and Great Patrick Street, Belfast  
(Abandonment) Order (Northern Ireland) 2021**

*Made* - - - - *13th May 2021*

*Coming into operation* - *23rd June 2021*

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Articles 68(1) and (5) of the Roads (Northern Ireland) Order 1993<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department in accordance with Article 68(4) of that Order proposes to abandon the areas of road described in the Schedule as they are not necessary.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

**Citation and commencement**

1. This Order may be cited as The Dunbar Link and Great Patrick Street, Belfast (Abandonment) Order (Northern Ireland) 2021 and shall come into operation on 23rd June 2021.

**Application**

2. The areas of road described in the Schedule is abandoned.

3.—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned area of road shall be retained.

(2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.

Article 2

### AREAS OF ROAD TO BE ABANDONED

Two areas of former footpath totalling 253.24 square metres at Dunbar Link, Belfast comprising of—

- (a) 147.843 square metres of former footpath at the junction of Dunbar Link and Great Patrick Street (hatched red on map number IN1/21/86944); and
- (b) 105.397 square metres of former footpath at the junction of Dunbar Link and Exchange Street (cross hatched green on map number IN1/21/86944).

A copy of the map has been deposited at the Department's Headquarters, Room 301, Clarence Court, 10-18 Adelaide Street, Belfast and at DfI Roads and Rivers Eastern Division, Annexe 7 Block 2, Castle Buildings, Stormont Estate, Upper Newtownards Road, Belfast.
