**The Parking Places, Loading Bay and Waiting Restrictions
(Downpatrick) (Amendment) Order (Northern Ireland) 2021**

Made - - - - - *22nd September 2021*

Coming into operation - *13th October 2021*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking Places, Loading Bay and Waiting Restrictions (Downpatrick) (Amendment) Order (Northern Ireland) 2021 and shall come into operation on 13th October 2021.

Amendment

2. Schedule 3 to The Parking Places, Loading Bay and Waiting Restrictions (Downpatrick) Order (Northern Ireland) 2017^(d) is amended by the addition of the following items—

- “13. Gaol Lane (east side) – from a point 15 metres south-east of its junction with Mount Crescent for a distance of 24 metres in a southerly direction.
- 14. Gaol Lane (west side) – from a point 15 metres south-east of its junction with Mount Crescent for a distance of 20 metres in a southerly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places, Loading Bay and Waiting Restrictions (Downpatrick) Order (Northern Ireland) 2017 (“the Order”) by the addition of a no waiting at any time (loading and unloading permitted) restriction on lengths of Gaol Lane, Downpatrick as specified in Article 2.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
