**ROAD TRAFFIC AND VEHICLES**

**The Roads (Speed Limit) (No. 2) Order (Northern Ireland) 2022**

*Made* - - - - *30th August 2022*

*Coming into operation* - *21st September 2022*

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Articles 37(3), 37(4) and 38(1) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 5 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No objection or other representation has been received.

**Citation and commencement**

1. This Order may be cited as the Roads (Speed Limit) (No. 2) Order (Northern Ireland) 2022 and shall come into operation on 21st September 2022.

**Application of speed limits**

2. The driving of motor vehicles at a speed exceeding 20 miles per hour on the lengths of road specified in Schedule 1 are prohibited.

3. The driving of motor vehicles at a speed exceeding 40 miles per hour on the length of road specified in Schedule 2 is prohibited.

**Revocations**

4. The provisions described in Schedule 3 are revoked.

Article 2

### Roads subject to a speed limit of 20 miles per hour

1. Park View, Unclassified No. 5342, Castledawson.
2. Riverside Gardens, Unclassified No. 5342, Castledawson
3. Riverside North, Unclassified No. 5342, Castledawson
4. Riverside South, Unclassified No. 5342, Castledawson
5. Redford Park, Unclassified No. 1144, Moy.

## SCHEDULE 2

Article 3

### Length of road subject to a speed limit of 40 miles per hour

Kilmasally Road, Unclassified No. 622, Ardboe – from a point 305 metres east of its junction with Mullanahoe Road, Route B161, to its junction with Killycanavan Road, Unclassified No. 621.

This Order—

- (a) applies a speed limit of 20 miles per hour to the lengths of road specified in Schedule 1;
- (b) applies a speed limit of 40 miles per hour to the length of road specified in Schedule 2;  
and
- (c) revokes the provisions in Schedule 3.

- 1.** The speed limit on Park View, Castledawson (paragraph 1 of Schedule 3) is now set at 20 miles per hour.
- 2.** The speed limit Riverview North, Castledawson (paragraph 2 of Schedule 3) is now set at 20 miles per hour.
- 3.** The speed limit on the length of Kilmascally Road, Ardboe (paragraphs 3 and 4 of Schedule 3) is now set at 40 miles per hour.
