**ROAD TRAFFIC**

**The A977 Trunk Road (Feregait and Toll Road, Kincardine)  
(Temporary Prohibition of Waiting, Loading and Unloading)  
Order 2013**

*Made* - - - - *25th February 2013*

*Coming into force* - - *10th March 2013*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the Schedule should be prohibited from waiting, loading or unloading because works are being or are proposed to be executed on or near the said length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the A977 Trunk Road (Feregait and Toll Road, Kincardine) (Temporary Prohibition of Waiting, Loading and Unloading) Order 2013, comes into force on 10th March 2013 and ceases to have effect on 18th March 2013.

**Temporary prohibition**

2. No person may use, or permit the use of, any vehicle to wait, load or unload on the length of road, or a part or parts of the length of road, specified in the Schedule when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of one or more of the traffic signs prescribed in Diagrams 636 and 636.1 of the Traffic Signs Regulations 2002.

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

### **Exemptions**

**3.** No prohibition imposed by this Order applies to—

- (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
- (b) a vehicle being used for carrying out the works.

## SCHEDULE

Article 2

### SPECIFIED LENGTH OF ROAD

The A977 Longannet Roundabout – Gartarry Roundabout Trunk Road from the extended south kerblineline at Broomknowe Drive, Kincardine generally south eastwards on Feregait and Toll Road to the junction with the A985 Kincardine – Rosyth Trunk Road at Longannet Roundabout, a distance of 2.5 kilometres or thereby.
