ROAD TRAFFIC

The A96 Trunk Road (Brodie) (50mph Speed Limit) Order 2017

Made - - - - *9th January 2017*

Coming into force - - *23rd January 2017*

The Scottish Ministers make the following Order in exercise of the powers conferred by section 84(1)(a), and 124(1)(d) of, and paragraph 27 of schedule 9 of, the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 84(2)(b) of the Road Traffic Regulation Act 1984, the Scottish Ministers have given public notice of their intention to make the following Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(c).

Citation and commencement

1. This Order may be cited as the A96 Trunk Road (Brodie) (50mph Speed Limit) Order 2017 and comes into force on 23rd January 2017.

Speed restriction

2. No person may drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road specified in the schedule to this Order.

Revocation

3. The A96 Trunk Road (Brodie) (50mph Speed Limit) Order 1996(d) is revoked.

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Exemption

4. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011^(a) when used in accordance with regulation 3(5) of those Regulations.

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A96 Aberdeen - Inverness Trunk Road at Brodie from a point (at Ordnance Map coordinates 57.592920, -3.704870) 378 metres or thereby east of the centreline of its junction with the C9E Muirside Road to a point (at Ordnance Map coordinates 57.590942, -3.717150) 428 metres or thereby west of the centreline of its junction with C9E Muirside Road, a distance of 806 metres or thereby.
