

# Freedom of Information Act 2000 (FOIA) Decision notice

Date: 18 September 2019

**Public Authority:** City and County of Swansea

#### **Decision (including any steps ordered)**

- 1. The complainant requested information about the City and County of Swansea's (the Council) NEAT team.
- 2. The Commissioner's decision is that the Council has breached section 10(1) of the FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the Council to take the following step to ensure compliance with the legislation.
  - The Council must provide a substantive response to the request in accordance with its obligations under the FOIA.
- 4. The Council must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.



### **Request and response**

5. On 31 May 2019, the complainant wrote to the Council and requested information in the following terms:

"On what legal basis are the people participating in the NEAT and baling plant schemes exempted from paying the new charge for day service provision? Please provide a copy of any protocol or policy, if relevant.

How many participants on these two schemes (NEAT and baling plant) have moved to paid positions within the council (or elsewhere) since inception?

How many of the participants on the NEAT and baling plant schemes have Care Plans drawn up in compliance with section 54 of the Social Service and Wellbeing (Wales) Act 2014?"

6. The Council did not acknowledge the request. On 28 June 2019, the complainant contacted the Council to ask for an update on the response. To date, a substantive response has not been issued.

# Scope of the case

- 7. The complainant contacted the Commissioner on 22 July 2019 to complain about the Council's failure to respond to their request.
- 8. The Commissioner has considered whether the Council has complied with its obligations in relation to the time for compliance at section 10(1) of the FOIA.

#### Reasons for decision

9. Section 1(1) of the FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."



- 10. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 11. On 8 August 2019 the Commissioner wrote to the Council, reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days.
- 12. Despite this intervention the Council has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that the Council did not deal with the request for information in accordance with the FOIA. The Commissioner finds that the Council has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with the FOIA.



## Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
