ROAD TRAFFIC

**The A1(M) Motorway (Junction 61 to Junction 60) (Temporary
Restriction and Prohibition of Traffic) Order 2011**

Made - - - - *13 January 2011*

Coming into force - - *23 January 2011*

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1(M) Motorway and connecting roads, in the County of Durham, is satisfied that traffic on that motorway and some of those connecting roads should be restricted and prohibited because carriageway resurfacing works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

1. This Order may be cited as the A1(M) Motorway (Junction 61 to Junction 60) (Temporary Restriction and Prohibition of Traffic) Order 2011 and shall come into force on 23 January 2011.

2. In this Order; -

“the A1(M)” means the A1(M) Motorway;

“the first length of southbound carriageway” means the A1(M) southbound carriageway from a point 1765 metres north of the centreline of the northern overbridge at Junction 61 (Bowburn) southwards for a distance of 1765 metres;

“the second length of southbound carriageway” means the A1(M) southbound carriageway from the nose of the southbound exit slip road at Junction 61 to the nose of the southbound entry slip road at Junction 60, a distance of approximately 10421 metres;

“the first slip road” means the A1(M) southbound exit slip road at Junction 61;

“the second slip road” means the A1(M) southbound entry slip road at Junction 61;

“the works period” means a period of 10 hours starting at 20:00 hours on Monday 24 January 2011 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour in the first length of southbound carriageway or the first slip road.

4. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the second length of southbound carriageway or the second slip road.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs. Nothing in article 4 shall not apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 3 shall apply to a vehicle being used for the purpose specified in paragraph (a) of this article.
