**The Government Resources and Accounts Act 2000 (Estimates
and Accounts) Order 2011**

<i>Made</i> - - - -	<i>10th March 2011</i>
<i>Laid before Parliament</i>	<i>11th March 2011</i>
<i>Coming into force</i> - -	<i>1st April 2011</i>

The Treasury, in exercise of the powers conferred by section 4A(3) and (4) of the Government Resources and Accounts Act 2000(a), make the following Order.

In accordance with section 4A(8) of that Act the Treasury have consulted, where they think it appropriate, the Scottish Ministers, the Department of Finance and Personnel for Northern Ireland and the Welsh Ministers.

Title and commencement

1.—(1) This Order may be cited as The Government Resources and Accounts Act 2000 (Estimates and Accounts) Order 2011.

(2) It comes into force on 1st April 2011.

Designations

2. A body listed in column 2 of a table in the Schedule is a designated body in relation to the department named in column 1 of that table for the financial year that ends on 31st March 2012.
