**The Air Navigation (Restriction of Flying) (Farnborough Air Show) (Amendment No. 2) Regulations 2012**

*Made - - - - at 14.55 hours on 13th July 2012*

*Coming into force with immediate effect*

The Secretary of State deems it necessary in the public interest to restrict flying in the vicinity of Farnborough Aerodrome, Hampshire, by reason of the holding of flying displays that are scheduled to take place between 2nd and 16th July 2012.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order 2009(a).

**Citation and commencement**

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Farnborough Air Show) (Amendment No. 2) Regulations 2012 and come into force with immediate effect.

**Amendment of Regulations**

2.—(1) The Air Navigation (Restriction of Flying) (Farnborough Air Show) Regulations 2012(b) are further amended as follows.

(2) In regulation 3(1), for sub-paragraphs (h) to (l) as amended, substitute—

- “ (h) between 1615 hours and 1900 hours on 13th July 2012, no aircraft is to fly within any of 1 and 2 airspace;
- (i) between 0700 hours and 1130 hours on 14th July 2012, no aircraft is to fly within any of 1 and 2 airspace;
- (j) between 1130 hours and 1645 hours on 14th July 2012, no aircraft is to fly within any of 1 to 7 airspace;
- (k) between 1645 hours and 1800 hours on 14th July 2012, no aircraft is to fly within either 8 or 9 airspace,
- (l) between 0700 hours and 1130 hours and between 1645 hours and 1800 hours on 15th July 2012, no aircraft is to fly within either 8 or 9 airspace;
- (m) between 1130 hours and 1645 hours on 15th July 2012, no aircraft is to fly within any of 1 to 7 airspace; and

- (n) between 0700 hours and 1600 hours on 16th July 2012, no aircraft is to fly within either 8 or 9 airspace.”.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations further amend the Air Navigation (Restriction of Flying) (Farnborough Air Show) Regulations 2012 (S.I. 2012/194, as amended by S.I. 2012/1958) (“the principal Regulations”). The amendment changes the timing of airspace restrictions on 13th and 14th July 2012 during the rehearsals for the biennial Farnborough Air Show organised by the Society of British Aerospace Companies Limited. No other substantive changes are made to the principal Regulations.

Full details of the restricted airspace will be promulgated by Aeronautical Information Circular and NOTAM.
