**The A46 Trunk Road (Sedgeberrow, Worcestershire)
(Temporary Restriction and Prohibition of Traffic) Order 2014**

Made - - - - *21st March 2014*
Coming into force - - *28th March 2014*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A46 Trunk Road (“the A46”), is satisfied that traffic on a length of that road, at Sedgeberrow in the County of Worcestershire, should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A46 Trunk Road (Sedgeberrow, Worcestershire) (Temporary Restriction and Prohibition of Traffic) Order 2014 and shall come into force on Friday 28th March 2014.

2. In this Order –

“the trunk road” means the northbound and southbound carriageways of the A46 between its roundabout junction with the A4184 Cheltenham Road and 50 metres south of its junction with Broadway Road and the unnamed road at Hinton Cross;

“the footway” means a way comprised in a highway which also comprises a carriageway, being a way over which the public have a right of way on foot only. The footway is adjacent to the trunk road and will be closed at sections totalling 661 metres in length;

“layby” means an area of carriageway intended for the waiting of vehicles and bounded partly by a traffic sign of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(b) and partly by the outer edge of that

carriageway on the same side of the road as that on which the sign is placed; and in this definition "carriageway" means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

"the works period" means the period starting at 00:01 hours on Friday 4th April 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 8 and 9, no person shall, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the trunk road.

4. Subject as mentioned in articles 8 and 9, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road.

5. Subject as mentioned in articles 8 and 9, no person shall, during the works period, cause or permit any pedestrian to enter or proceed in the footway.

6. Subject as mentioned in article 8 and 9, no person shall, during the works period, cause or permit any vehicle to enter or proceed in any layby situated adjacent to the trunk road.

7. Subject as mentioned in articles 8 and 9, no person shall, during the works period, cause or permit any vehicle to enter or leave the southbound carriageway of the A46 at its junction with Broadway Road.

8. The provisions of articles 3, 4, 5, 6 and 7 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

9. The provisions of –

a) article 3 shall not apply to any vehicle being used for special forces purposes;

b) articles 3, 4, 5, 6 and 7 shall not apply to any vehicle –

a. being used for police, fire brigade or ambulance purposes; or

b. proceeding at the direction of, or with the permission of, a police constable;

c) articles 4, 5, 6 and 7 shall not apply to any vehicle being used in connection with the said works;

d) article 4 shall not apply to any vehicle proceeding to and from premises which are accessible from, and only from, the trunk road;

e) article 5 shall not apply to –

(i) any pedestrian engaged in police, fire brigade or ambulance activities;

- (ii) any pedestrian acting under the direction of, or with the permission of, a police constable;
- (iii) personnel engaged in the said works; and
- (iv) any pedestrian proceeding to and from premises which are accessible from, and only from, the trunk road.
