### The Occupational and Personal Pension Schemes (General Levy) (Revocation) Regulations 2020

The Secretary of State for Work and Pensions makes the following Regulations in exercise of the powers conferred by sections 175(1) to (3) and 182(2) of the Pension Schemes Act 1993<sup>(1)</sup>.

The Secretary of State considers that consultation in respect of these Regulations is inexpedient because of urgency<sup>(2)</sup>.

#### **Citation and commencement**

1. These Regulations may be cited as the Occupational and Personal Pension Schemes (General Levy) (Revocation) Regulations 2020 and come into force on 31st March 2020.

#### **Revocation of the Occupational and Personal Pension Schemes (General Levy) (Amendment) Regulations 2020**

2. The Occupational and Personal Pension Schemes (General Levy) (Amendment) Regulations 2020<sup>(3)</sup> are revoked.
